



Equipment Operator II – Non-DOT
Street
Wage Rate: \$11.21/hour

JOB SUMMARY

This position is responsible for operating equipment for cutting grass and weeds along City right-of-ways.

MAJOR DUTIES

- Operates a tractor and/or bush-hog to cut grass and weeds.
- Clears ditches along roadways.
- Removes tree limbs and brush.
- Maintains roads and trails on spray field.
- Maintains fences and gates.
- Assists in the maintenance of pipes and sprayer heads.
- Maintains and repairs tractor and other equipment.
- Performs related duties.

KNOWLEDGE REQUIRED BY THE POSITION

- Knowledge of equipment operation principles.
- Knowledge of equipment maintenance principles.
- Knowledge of water and wastewater line repair.
- Knowledge of city and departmental policies and procedures.
- Knowledge of work safety principles.
- Skill in the use of a variety of job-related equipment.
- Skill in the analysis of problems and the development and implementation of solutions.
- Skill in the use of a variety of job-related hand and power tools.

SUPERVISORY CONTROLS

The Crew Leader or Supervisor assigns work in terms of somewhat general instructions. The supervisor spot-checks completed work for compliance with instructions and established procedures, accuracy, and the nature and propriety of the final results

GUIDELINES

Guidelines include city and department policies and procedures, and safe work practices. These guidelines are generally clear and specific, but may require some interpretation in application.

COMPLEXITY/SCOPE OF WORK

- The work consists of related maintenance and equipment operation duties. Inclement weather and heavy traffic contribute to the complexity of the position.
- The purpose of this position is to assist in the maintenance of city streets and rights-of-way. Successful performance contributes to well-maintained city streets.

CONTACTS

- Contacts are typically with co-workers and other city employees.
- Contacts are typically to provide services or to resolve problems.

PHYSICAL DEMANDS/ WORK ENVIRONMENT

- The work is typically performed while bending, crouching or stooping. The employee frequently lifts light and heavy objects, climbs ladders, and uses tools or equipment requiring a high degree of dexterity.
- The work is typically performed outdoors, occasionally in cold or inclement weather. The employee may be exposed to noise and machinery with moving parts. Work requires the use of protective devices such as masks, goggles, gloves, etc.

SUPERVISORY AND MANAGEMENT RESPONSIBILITY

None.

MINIMUM QUALIFICATIONS

- High School diploma or GED.
- Sufficient experience to understand the basic principles relevant to the major duties of the position, usually associated with the completion of an apprenticeship/internship or having had a similar position for one to two years.
- Possession of or ability to readily obtain a valid driver's license issued by the State of Georgia for the type of vehicle or equipment operated.
