I hereby certify that I am the Owner of the above-referenced property (hereinafter, "Property") and possess the legal authority to authorize and grant permission for the use of said Property by other parties. Pursuant to this authority, I hereby authorize the above-referenced Mobile Food Vendor to operate on the Property subject to a schedule of my choosing, provided that I shall not schedule the Mobile Food Vendor to operate outside of the hours of 8:00 am and 8:00 pm. I understand that, while I may authorize more than one mobile food vendor to operate on the Property, only one mobile food vendor may operate on the Property *at a time*. Further, in the event the City determines that more than one vendor is operating, the City may require all vendors to leave the Property, and I hereby release the City from any and all claims of civil damages which may arise between me, as owner of the property, and any mobile food vendor authorized to operate on the Property.

I hereby affirm that the Property does not contain any vacant or unused structure as the term is described in Sec. 22-249, Code of Griffin. I understand and acknowledge that I am responsible for the condition of my property and may be cited for any violations of zoning, building, health, sanitation, or life safety codes under the laws of the City of Griffin or the State of Georgia, whether or not it is related to the operation of a mobile food vendor. In the event the Mobile Food Vendor fails to cleanup or dispose of litter associated with its operations on my Property, I will ultimately be responsible and may be cited for code violations or nuisance conditions. I understand and acknowledge that vending structures, including but not limited to, food trucks, pushcarts, tables, or other structures or vehicles associated with the operation of the Mobile Food Vendor may not be stored on my property during restricted hours of operation or when the Mobile Food Vendor is not operating.

I acknowledge and affirm that failure to abide by the terms of Article III, Chapter 54, Code of Griffin, will result in a citation before the City of Griffin Municipal Court and that the City has the authority to cite me and/or my business for violations in lieu of or in addition to citations issued to the Mobile Food Vendor. I further acknowledge that any accumulation of violations related to the operation of any mobile food vendor on my Property shall be deemed a nuisance, and the City may request an order prohibiting me from using my Property for any mobile food vendor until a plan to remedy and prevent the violations has been submitted and approved by the Court.
